- Approve meeting minutes July 27, 2024 Motion was made by Jeff and seconded by Jeremy (FD1), Jody (FD2) to approve the July 27, 2024 Joint Meeting Minutes. Motion carried in the affirmative.

- 5. Budget Status Both boards reviewed with no questions.
- 6. Report from Operator

 - b. Update on Source Protection Plan (both) The Source Protection Plan is under review with the State of Vermont. Diana and Noreen will update the List of Users within the Water Districts.
 - c. Water issue 144 Hall Stream Rd (FD2) No change since last meeting.
 - d. Water issue 29 East Street (FD2) The shut off to this property is located on the other side of East Street and the owner would like to install a shut off on his side of the road.

- e. Update on water meters (FD2) All meters have been installed. In order for them to be read the information will need to be entered in the NEMRC system. The board approved paying Diana with some of the remainder ARPA funds for the project.
