- Open Meeting Chairman Vernon Crawford opened the June 10, 2024 Rec Park

- II. Additions or Deletions to the Agenda See other business.
- III. Approve minutes for the May 17, 2024 Meeting On a motion by Diana and seconded by Vern the meeting minutes were approved unanimously as written.
- IV. Status on splash pad project Jim Wells informed Vern that he wouldn't be able to work on the Splash Pad Project until the end of August beginning of September. He suggested talking to Laurent Rancourt. Vern contacted both Laurent Rancourt and Wayne Dorman and they will work on the project along with him. A quote was received from Rancourt Sand & Gravel, LLC for \$25,270.00. Norman Flangan will be contacted regarding the plumbing. Diana mentioned that Canaan Naturally Connected would like to help with the ribbon cutting ceremony and they thought that July 27th would be a good day. After some discussion it was decided not to commit to a date until the project is complete. Once the project is complete a meeting will be held to discuss the ribbon cutting ceremony.
- V. Porta potty quotes Diana shared the quotes that Brian Riff emailed her from C.D.S. Portable Toilets. Regular Unit \$1275, Handicap Accessible Unit \$2640, ADA Unit \$3025, these prices include the unit and shipping. Diana will get quotes from Juddy.
- VI. Cordless vacuum cleaner Decided not to order at this time.
- VII. Dig Safe April has renewed the ticket for Dig Safe for another thirty days.
- VIII. Camping regulations Vern looked over the camping regulations and no changes were needed.
- IX. Rec park street sign Sign has been ordered and should be arriving shortly.
- X. Playground chips Diana shared the playground chip quote from Durgin and Crowell Lumber Co. from New London, NH and it was decided that only 20 yards were needed.
