**FINDINGS**

- a) On January 11, 2012, the Solid Waste Management Program (Program) issued a certification for the continued operation of the Canaan Transfer Station; a Facility that collects MSW, recycling, universal wastes and hosts HHW collection events.
- b) On June 4, 2015, the Permittee applied for an Amendment to the Certification for the construction and operation of a HHW/CEG Waste storage operational unit at the Facility. The components listed in Finding a above and the HHW/CEG Waste storage unit constitute the Facility.
- c) On June 4, 2015 the Program determined that the application was administratively and technically complete and that it conforms to the Rules and other applicable statutory and regulatory requirements.
- d) Pursuant to 10 V.S.A. §6605(c), the Program finds that the Facility is included in the Town of Canaan's Solid Waste Implementation Plan.
- e) The Permittee submitted a revised closure cost estimate and plan to include the HHW/CEG Waste collection in accordance with Subchapter 10 of the Rules. The closure plan for the Facility is in conformance with the requirements of the Rules and applicable Solid Waste Management Procedures.
- f) The Permittee furnished a statement from Noreen Labrecque, the Town Treasurer, stating the Town of Canaan has \$8,000 available to fund the 2015 approved closure plan.

- g) On DATE, the Permittee provided notice of the draft certification pursuant to the requirements of Sections 6-305(b) and 6-304(h) (1) of the Rules. The comment period ended on DATE.

### **CONDITIONS & REQUIREMENTS FOR CONSTRUCTION & OPERATION**

1. All Findings and Conditions of the January 11, 2012 Certification remain in full force and effect with the following amendments to existing conditions and additional conditions set forth herein.
2. The following documents, submitted as part of the Application, are hereby incorporated by reference in this certification:
  - *Canaan Transfer Station Certification Application*, submitted September 13, 2012.
  - *Application for Amendment to the Certification*, submitted June 4, 2015.
  - *Revised Management Plan*, submitted June 9, 2015.

Additions or alterations to the documents referenced above must be approved by the Agency prior to implementation. Materials or substantial additions or alterations which justify the application of condition different or absent from the Certification will be cause for modification or amendment of this Certification.

### **Materials Management**

3. Condition 21 of the January 11, 2012 Certification shall be replaced with the following:

#### **HHW/CEG Hazardous Waste Collection**

21. The Facility is authorized to collect HHW/CEG hazardous waste materials. The Permittee shall manage all HHW and CEG hazardous wastes in accordance with the Facility Management Plan, Section 6-1206(d) of the Rules and with Subchapters 1, 2, 3, 4, 6, 7, 8 and 9 of the VHWMR as applicable.

### **Appeals**

Any person aggrieved by this certification or permit may appeal to the Superior Court – Environmental Division within 30 days of the issuance of this permit in accordance with 10 V.S.A. Chapter 220 and the Vermont Rules Environmental Court Proceedings. If this certification or permit relates to a renewable energy plant for which a certificate of public good is required under 30 V.S.A. §248, any appeal must be filed within 30 days of the issuance with the Vermont Public Service Board in accordance with Board rules.

The Secretary's issuance of this Certification for the operation of this facility relies upon the data, judgment and other information supplied by the Permittee(s), the hired professional consultants and other experts who have participated in the preparation of the Application.

The Secretary makes no assurances that the facility certified herein will meet the performance objectives of the Permittee(s) and no warranties or guarantees are given or implied.

The Program staff has reviewed the Application and has found that it conforms to current technical standards. It is recommended that the foregoing findings be made and this Certification be issued for the operation of the facility described here in.
