**THE REVISED/UPDATED ORDINANCE REGULATING THE DISPOSAL OF SEWAGE AND THE USE OF THE PUBLIC SEWERAGE SYSTEM IN THE TOWN OF CANAAN, VT WAS ADOPTED ON MAY 23, 2016 AT THE BI WEEKLY SELECTBOARD MEETING. IF A PETITION IS RECEIVED, THE TOWN OF CANAAN WILL WARN A MEETING AND THE VOTERS MAY VOTE ON THAT QUESTION "24 V.S.A SECTION 1972".**
