THE PRUDENTIAL COMMITTEE OF CANAAN FIRE DISTRICT #2 A MUNICIPAL ENTITY FORMED AND EXISTING PURSUANT CHAPTER 171 TO TITLE 20 VERMONT STATUTES ANNOTATED, HEREBY ADOPTS THE RULES, REGULATIONS AND SCHEDULE OF RATES AND CHARGES, AS THE SAME MAY BE AMENDED FROM TIME TO TIME, GOVERNING USE, OPERATION AND ADMINISTRATION OF THE COMMUNITY WATER SYSTEM SERVING THE PROPERTY OWNERS WITHIN THE FIRE DISTRICT. THE REVISED/UPDATED RULES AND REGULATIONS AND SCHEDULE OF RATES AND CHARGES IN THE CANAAN FIRE DISTRICT #2 WAS ADOPTED ON AUGUST 16, 2017 AT THE MONTHLY CANAAN FIRE DISTRICT #2 MEETING. OCTOBER 15, 2017 UNLESS A PETITION SIGNED BY AT LEAST FIVE PERCENT OF VOTERS OF THE CANAAN FIRE DISTRICT #2 IS FILED WITH THE FIRE DISTRICT CLERK BY SEPTEMBER 29, 2017 ASKING FOR A VOTE TO DISAPPROVE THE ORDINANCE. IF A PETITION IS RECEIVED, THE TOWN OF CANAAN FIRE DISTRICT #2 WILL WARN A MEETING AND THE VOTERS MAY VOTE ON THAT QUESTION "24 V.S.A SECTION 1973".
